OAKLAND CITY COUNCIL JULY 14, 2025 REGULAR SESSION

The Regular Session of the Oakland City Council met in the Oakland City Services Building and was called to order by Mayor Brant Miller at 7:00p.m. Pledge of Allegiance was said. Council Members present were Applegate, Bernard, Ford, and Reed. Perkins was absent. City staff present were City Administrator/Clerk Marissa Lockwood and Public Works Director Josh Billings. Public present were Angela Miller, Hanna Bane, Tracy Van Zee, Dean Schechinger, Kevin Schechinger, Megan Wilson, Kyra Graves, Teegan Williams, Jill Weathers and Danielle Briggs with SWIPCO (electronically). Motion by Bernard, second by Applegate to approve the agenda. 4 ayes, motion carried.

Open forum was held. No public comments.

Motion by Reed to approve the consent agenda including June Clerk Report, July Claims, June Library Report, Golf Course Report, Sheriff's Report, Animal Control Report, minutes from June 9th regular session and June 25th special session, liquor license renewal for El Sol Family Restaurant LLC, Resolution 2025-07-01 "Bank Signers" and Resolutions 2025-07-02, 2025-07-03 and 2025-07-04 "Placing Liens on Properties". Second by Ford. Roll call. 4 ayes, motion carried.

Public hearing concerning the application for a CDBG grant for the water distribution system improvements project was opened at 7:04p.m. Dani Briggs with SWIPCO provided information on the project. No public comments were received. Hearing was closed at 7:13p.m.

Members of the pool committee presented survey results to the Council. Next steps were discussed. Bernard will replace Reed on the committee due to Reed being out of town for work often. Pool committee will meet again on Monday, July 21 to continue moving forward.

Traffic Engineering Assistance Program crosswalk study was discussed. They will be looking at locations for a crosswalk near the library/park and pool/golf course. Motion by Bernard, second by Ford to approve the committee as Kari Rose, Lockwood, Billings, Miller and Austin Yates with the DOT. 4 ayes, motion carried.

Motion by Reed, second by Ford to approve Resolution 2025-07-05 "Authorizing Execution of an Amended Application for Voluntary Annexation of Certain City Property to the City of Oakland, Iowa, and Accepting the Same for Filing". Roll call. 4 ayes, motion carried. Public hearing concerning application for voluntary annexation of property to the City of Oakland, Iowa was opened at 8:16p.m. No public comments were received. Hearing closed at 8:17p.m. Motion by Applegate, second by Ford to approve Resolution 2025-07-09 "Approving an Application for Voluntary Annexation of Certain Land to the City of Oakland, Iowa". Roll call. 4 ayes, motion carried.

Public hearing on the authorization of a Loan and Disbursement Agreement and the issuance of Notes to evidence the obligation of the City thereunder was opened at 8:17p.m. No public comments were received. Hearing was closed at 8:18p.m. Motion by Reed to approve Resolution 2025-07-06 "Instituting Proceedings to take additional action" on Not to Exceed \$5,000,000 Water Revenue Capital Loan Notes. Second by Coralee. Roll call. 4 ayes, motion carried. Motion by Bernard, second by Applegate to approve submitting the SRF construction loan application for 2023 and 2024 Water Supply Wells projects. 4 ayes, motion carried.

Motion by Applegate to approve Resolution 2025-07-07 "Approving Contracts and Bonds" with Western Iowa Utilities Inc. for the 2023 Water Supply Wells project. Second by Reed. Roll call. 4 ayes, motion carried. Motion by Bernard, second by Reed to approve Resolution 2025-07-08 "Approving Contracts and Bonds" with Western Iowa Utilities Inc. for the 2024 Water Supply Wells project. Roll call. 4 ayes, motion carried.

Pay application 5 for the Wastewater Improvements Project – Lift Station Generators was reviewed. Motion by Reed, second by Applegate to approve pay application 5 to Vicker Drilling LLC for \$75,972.51.4 ayes, motion carried.

Bids were reviewed for concrete repairs at the fire station. Motion by Reed to approve the bid from Joe Zimmerman in the amount of \$116,696 pending confirmation that this includes rebar 2 foot on center and that work can begin in October. Second by Ford. 4 ayes, motion carried.

Updates to the projects list were discussed for the Capital Improvements Plan. Lockwood will provide the list to McClure Engineering to be included in the CIP.

Discussion was held on the difference between an annual audit and annual examination. The state only requires an annual examination based on population and budget amount for the City of Oakland. The cost savings are nearly half the cost of the audit, and it is getting harder to find municipal auditors. Motion by Reed to have an annual examination with an audit every third year. Second by Ford. 4 ayes, motion carried.

Disposal of city owned property was discussed. The fire department has the old ambulance and Suburban to get rid of. Motion by Reed, second by Applegate to list them through an online auction. 4 ayes, motion carried.

Personnel discussion was held. Motion by Bernard to approve Resolution 2025-07-10 "Setting Employee Wages" giving Virgil Smith Jr. an increase of 3% for his 1-year evaluation, taking his salary to \$64,756.00. Second by Applegate. 4 ayes, motion carried.

Billings gave the Crew Report. Worked on getting things ready for the 4th of July celebration, filling potholes.

Lockwood gave the Clerk's Report. Election nomination papers can be accepted starting August 25th through September 18th. Iowa League of Cities conference in Des Moines September 17-19. On vacation July 28-August 1.

Miller gave the Mayor's Report. Thanked the committee that put together the 4th of July celebration this year. It went well and was great to have more events over two days. The fireworks show was disappointing for the high cost and will be looking in to making a change for future shows.

Motion by Ford, second by Bernard to adjourn. 4 ayes, motion carried. Adjournment 9:17p.m.
